Marks allotted by the examiner will be deemed final. Answer copies will not be returned to the participants.

Prizes will be divided into 5 categories

- 1st, 2nd & 3rd position holders in each group
- Distinction marks 75% and above, • Merit marks 50% and above
- Passing marks 33% and above, • Less than 33%
